JXHTML EDIT 2.0 SOFTWARE LICENSE AGREEMENT

This Tecnick.com S.r.l. ("Tecnick.com") Software License Agreement (the "Agreement") is a legal agreement between the individual or entity licensing the product ("Licensee") and Tecnick.com for this Tecnick.com software product ("Software").

By installing, copying, or otherwise using the Software, Licensee agree to be bound by the terms of this Agreement. If Licensee does not agree to all of the terms of this Agreement, the Licensee must not install, copy or use this software.

1. DEFINITIONS

1. In this Agreement "Licensor" shall mean Tecnick.com S.r.l. located in Via Ugo Foscolo n.19 - CAP 09045 Quartu Sant'Elena (CA) - ITALY - P.IVA 02574420929, unless the Licensee acquired the Product as a bundled component of a third party product or service, then such third party shall be Licensor;
2. The term "Licensee" indicate the individual or entity licensing the Software product.
3. The term "Software" indicate this computer software product and may include associated media, printed materials and "online" or electronic documentation ("Documentation"). The term "Software" shall also include any upgrades, modified versions, updates, additions, and copies of the Software licensed to Licensee by Tecnick.com.

2. COPYRIGHT

1. The Software is owned by Tecnick.com and its suppliers, and its structure, organization and code are the valuable trade secrets of Tecnick.com and its suppliers.
2. The Software is also protected by Italian Copyright, EC Copyright Law and International Treaty provisions.
3. Licensee may not copy the Software or the Documentation, except as set forth in the "LICENSE GRANT" section. Any copies that Licensee are permitted to make pursuant to this Agreement must contain the same copyright and other proprietary notices that appear on or in the Software.
4. Trademarks shall be used in accordance with accepted trademark practice, including identification of trademark owner's name. Trademarks can only be used to identify printed output produced by the Software. Such use of any trademark does not give Licensee any rights of ownership in that trademark.
5. All other company and product names are trademarks or registered trademarks of their respective companies.
6. Except as stated above, this Agreement does not grant Licensee any intellectual property rights in the Software.
7. The use of any included third party software product shall be governed by the third party's license agreement and not by this Agreement.

3. LICENSE GRANT

Licensee may:

1. Install the Software in one or more computer storage devices up to the number of installations indicated in the upper left hand corner ("permitted number of installations") of this Agreement.
2. Make one backup copy of the Software, provided that this backup copy is not installed or used on any computer.
3. Not rent, lease, sublicense or lend the Software or Documentation. Licensee may, however, transfer all his rights to use the Software to another person or legal entity provided:
 - a. that Licensee transfer this Agreement, the Software, including all copies, updates and prior versions and all Documentation to such person or entity;
 - b. that Licensee retain no copies, including copies stored on a computer;
 - c. that the receiving party accept the terms and conditions of this Agreement.

4. RESTRICTIONS

Except as otherwise expressly permitted in this Agreement, or in another Licensor agreement to which Licensee is a party such as a distribution agreement, Licensee may not:

1. installing Software more than permitted number of installations indicated in the upper left hand corner ("permitted number of installations") of this Agreement.
2. using Software for more than permitted number of network addresses (URL - Uniform Resource Locator) installations indicated in the upper left hand corner ("permitted number of installations") of this Agreement.
3. decompile, disassemble, reverse engineer, or otherwise attempt to derive the source code for the Product (except to the extent applicable laws specifically prohibit such restriction);
4. redistribute, encumber, sell, rent, lease, sublicense, or otherwise transfer rights to the Product;
5. remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels in the Product;
6. publish any results of benchmark tests run on the Product to a third party without Licensor's prior written consent.

5. DISCLAIMER OF WARRANTY

1. The software is provided on an "as is" basis without warranty of any kind except herein indicated, including without limitation the warranties of merchantability and fitness for a particular purpose and any warranty of non-infringement.
2. Tecnick.com and its suppliers do not and cannot warrant the performance or results that may be obtained by using the software or documentation.
3. Licensor warrants to Licensee that the Software will perform substantially in accordance with the Documentation for the thirty (30) day period following the receipt of the Software.

4. If the Software does not perform substantially in accordance with the Documentation, Licensee may write to Licensor within such thirty (30) day period the receipt of the Software. The entire and exclusive liability and remedy shall be limited to either, at Licensor's option, the replacement of the Software or the refund of the license fee paid for the Software.
5. Except for the foregoing limited warranty, Tecnick.com and its suppliers make no warranties, express or implied, as to non-infringement of third party rights, merchantability, or fitness for any particular purpose.
6. Some states or jurisdictions do not allow the exclusion of implied warranties or limitations on how long an implied warranty may last, so the above limitations may not apply. In respect of any dispute which may arise hereunder, Licensee consent to the Italian jurisdiction of the court sitting in Cagliari.

9. TERMINATION

This Agreement shall automatically terminate upon failure by Licensee to comply with its terms. On termination, Licensee must destroy all copies of the Software and Documentation.

10. MISCELLANEOUS

1. This agreement represents the entire agreement concerning this license between the parties and supersedes all prior agreements and representations.
2. This Agreement may be amended only by a writing signed by both parties.
3. The controlling language of this Agreement is Italian. If Licensee has received a translation into another language, it has been provided for Licensee's convenience only.
4. This Agreement will be governed by the laws in force in Italy excluding the application of its conflicts of law rules.
5. If any part of this Agreement is found void and unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms.
6. If more than one license agreement was provided for the Software, and the terms vary, the order of precedence of those license agreements is as follows: a signed agreement, a printed or electronic agreement that states clearly that it supersedes other agreements, a printed agreement provided with the Software, an electronic agreement provided with the Software.
7. If any provision in this Agreement should be held illegal or unenforceable by a court having jurisdiction, such provision shall be modified to the extent necessary to render it enforceable without losing its intent, or severed from this Agreement if no such modification is possible, and other provisions of this Agreement shall remain in full force and effect.
